Vice-presidential candidate



Bridget María Chesterton is an associate professor of history at Buffalo State (SUNY). She is the author of *The Grandchildren of Solano López: Frontier and Nation in Paraguay, 1904-1936* (University of New Mexico Press, 2013.) She also is the editor of the new text *The Chaco War: Environment, Ethnicity, and Nationalism* (Bloomsbury Academic Publishing, 2016) and co-editor of *Transformations of Populism in the Europe and the Americas* (Bloomsbury Academic Publishing 2016). She also has published articles in the *Journal of Women's History* and the *Hispanic American Historical Review*. She is currently in Paraguay researching her newest project provisionally entitled "The Hotel Guaraní: The Urbanization and Brazilianization of Paraguay during the Stroessner Years."

Executive Committee candidates



Gerardo T. Cummings Rendón is Chair of the Spanish Program at Wells College. He is a generalist, although his research has concentrated on Mexican film, literature and culture as of late. He has given over fifty-four presentations in professional conferences in Canada, Mexico, and the United States and published over 30 academic articles, interviews, translations and book reviews on Latin American and Spanish literature and culture in national and international refereed journals from Puerto Rico, Spain, Costa Rica, Mexico and The United States. He has published Recuento historiográfico del Comisariado de Bienes Comunales y Consejo de Vigilancia de Huitzilac, Morelos: Trienio 2007-2010 and is currently editing Studies in the Horror Film: Mexican Horror Film. He has three other books awaiting publication: Luis Buñuel en el cine latinoamericano, Emiliano Zapata en el cine mexicano y universal: El héroe morelense en la pantalla and a compendium of Guillermo del Toro's cinema. He has been member of editorial boards for Femspec, Chiricú, Negritud, etc.



Silvia M. Peart (B. A., National University of Córdoba, M.A., Texas Tech University, Ph. D., Texas Tech University) is an Associate Professor of Spanish and Second Language Acquisition at the United States Naval Academy where she teaches courses on Latin American Culture, Linguistics, Lower Level Spanish and Special Topics Seminars. She is the Chair of the Research Special Interest Group (723 members) of the American Council on The Teaching of Foreign Languages (ACTFL). Her research and publications focus mainly on (1) gender variables in learners' cognitive progression when reading in a second language, (2) intercultural competence, and (3) identity construction in the literary production of Latino/a writers. She has been a member of MACLAS since 2008 and has collaborated with the organization in different roles over time.



James F. Siekmeier received his PhD from Cornell in 1993, where he studied the history of U.S. foreign relations under the direction of Walter LaFeber. He has published three books, and co-edited four documents collections on U.S.- Latin American relations as part of the Foreign Relations of the United States series, put out by the U.S. government. He has taught in Iowa, Texas, and Bolivia (Fulbright Senior Scholar Fellowships). Currently he is an Associate Professor of History at West Virginia University where he teaches courses on 20th century US history, in particular U.S. foreign relations; inter-American history; and Latin American history. He is currently working on a book manuscript, written for a student audience, which is an overview of the history of Latin American nationalism in a globalizing world.



- The second annual Summer Institute on Conflict Transformation Across Borders, offered by The McCormack Graduate School of Policy and Global Studies of the University of Massachusetts-Boston, FLACSO-Ecuador, and the Center for Mediation, Peace, and Resolution of Conflict (CEMPROC), will take place from June 5-24, 2016 in Quito, Ecuador at FLACSO, with graduate-level credit issued by UMass Boston. The program will focus on conflict and peace in border regions. More info and application instructions are available at http://www.caps.umb.edu/conflict_transformation. The application deadline is March 21, 2016.

The program is coordinated by Dr. Jeff Pugh of UMass Boston (Dept. of Conflict Resolution, Human Security, and Global Governance) and Dr. Cecile Mouly of FLACSO-Ecuador (Dept. of International Studies and Communication), and will feature a series of high-level guest speakers (a former Ecuadorian Minister of Foreign Relations, UN Ambassador, UN peacekeeper involved in the Nicaraguan demobilization process, refugee leaders, NGO activists, and more).

This course is designed to equip early-career professionals, graduate students, and other future peacebuilders with practical tools, knowledge, and hands-on experience to understand the complexities of conflicts within and across border regions, and the types of interventions that can be used to transform these conflicts.

The program will include classroom learning; trips to the Amazon cloud forest and the northern border region; practical skills training workshops on negotiation, cross-cultural communication, and proposal writing; and participants will design their own proposal for a peacebuilding project, receiving feedback from a panel of experienced experts in the field. In this sense, the Summer Institute is not just a learning or training opportunity, but a platform for action that connects a cohort of peacebuilders and empowers them to address the complex conflicts related to borders, migration and refugees, and transnational environmental challenges that face the world today.

- Human security vs. national security in border regions
- Transnational dimensions of conflict and peacebuilding
- Skills workshop: Conflict analysis
- Border disputes and binational dialogue/peace processes: the cases of Ecuador-Colombia and Ecuador-Peru
- Forced migration and social conflict in migrant-receiving communities
- Skills workshop: Negotiation and mediation
- Conflict involving transnational environmental challenges
- Skills workshop: Project development and proposal writing
- Indigenous identity, ethnicity and conflict in border regions
- Skills workshop: Cross-cultural and non-violent communication as peacebuilding resource
- Security sector reform; disarmament, demobilization, and reintegration (DDR) and the Colombian armed conflict
- Nonviolence and civil resistance
